Feeding Instructions:

Either continue to feed Breeders brand of food (Salmon & rice) or mix breeders food with new brand of food over a several days period, so you don't upset your puppy's tummy.

A spoonful of canned food may be mixed with the moistened dry food if necessary to encourage puppy to eat for the first few days.

Feed 3 times daily up to 4 months, always providing plenty of fresh water.

Pedigree:

Breeder guarantees said dog to be a purebred Australian Shepherd, breeder will supply buyer with a 3-generation pedigree on said dog, and ASCA and AKC puppy registration papers. This puppy will carry the prefix Colockum or Colockum's at the beginning of its registered name.

Health Guarantee:

Buyer agrees to have said puppy examined by a licensed veterinarian within 48 hours of purchase. If at that time the puppy does not pass inspection, said puppy maybe returned to seller/breeder at the buyer's expense for a full refund. A written explanation from the attending vet must be received by the seller/breeder before the puppy is returned. All actions taken to return the puppy shall be done with the best interest of the puppy in mind. Including temperature at time of shipping, non-stop flights, etc.

Hips & Elbows

Breeder hereby agrees and guarantees said dog to be free of hip dysplasia (a rating of Fair or above for hips, normal/normal for elbows). If said dog upon reaching the attained age of 2 years, is found to be dysplastic by use of a radiograph done by a qualified veterinarian competent in the diagnosis of the dysplasia, the breeder agrees to replace said dog with another dog of the same quality. Breeder has right to view the radiographs and if necessary (due to poor quality radiographs or poor positioning of the hips) the breeder has right to ask for another radiograph to be taken by another vet, on a different x-ray machine before replacing said dog. Breeder must receive proof of that the first dog is spayed or neutered before replacing it with another dog. If said dog is bred before 2 years of age, or before its hips and elbows are OFA'd, this contract and guarantee is null and void.

Eye Defects:

Breeder hereby agrees and guarantees said dog to be free from genetic eye defects. If said dog upon reaching 2 years of age is found to have genetic eye defect by a certified ophthalmologist that would not allow the dog to pass CERF requirements (does not include breeder option issues) the breeder agrees to replace said dog with a

dog of equal quality. Breeder must receive proof of that the first dog is spayed or neutered before replacing it with another dog. If said dog is bred before its eyes are certified or before 2 years of age, this contract and guarantee is null and void.

Teeth/Bite:

Breeder guarantees said show prospect dog to have either a scissor bite or level bite at 2 years of age and have not more than 2 missing teeth. If said dog has either of these conditions' breeder will upon proof of said condition and then proof the dog has been spayed or neutered replace said dog with a show prospect puppy of same gender. If said dog is bred before its 2 years old this contract will be null and void.

Additional terms:

If it becomes necessary for the buyer to part with this puppy/dog at anytime in the dog's life, the breeder must be notified and have first right of refusal for an amount not to exceed \$600.00
